SoCalBio is **open to membership** by firms and organizations engaged in life-science technology commercialization and service

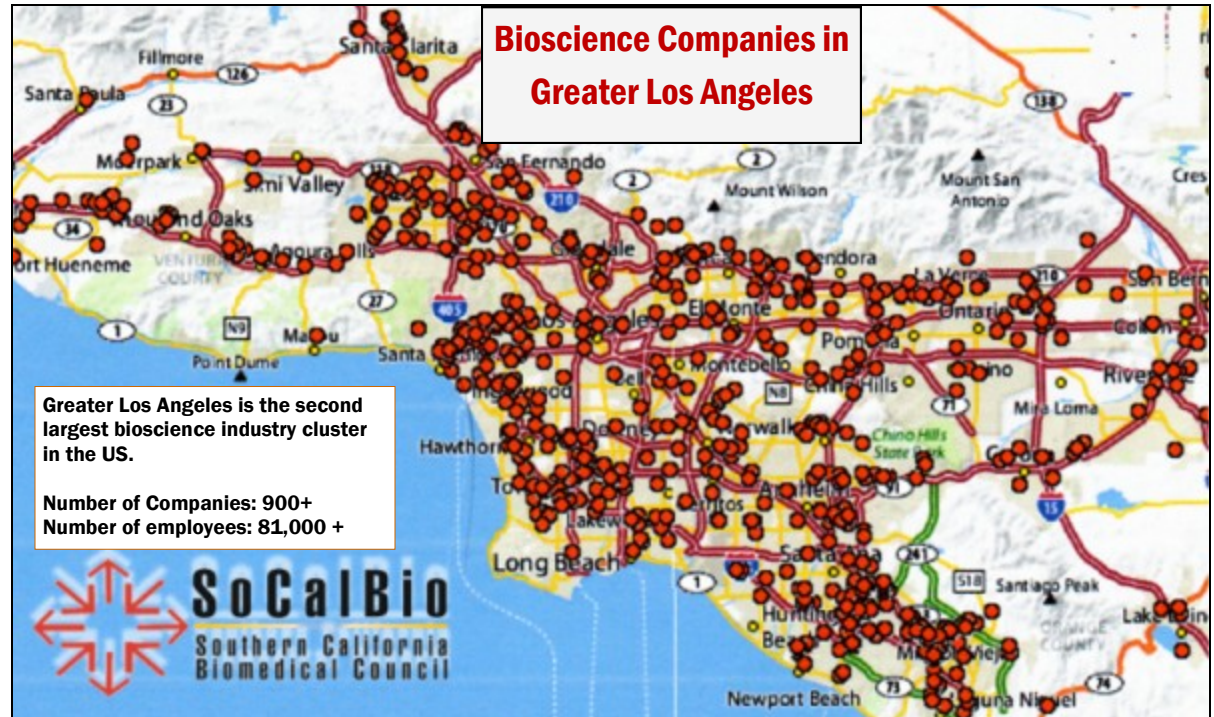

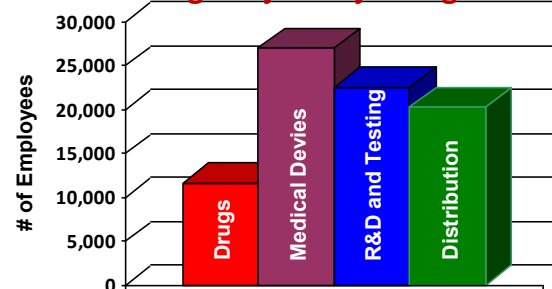

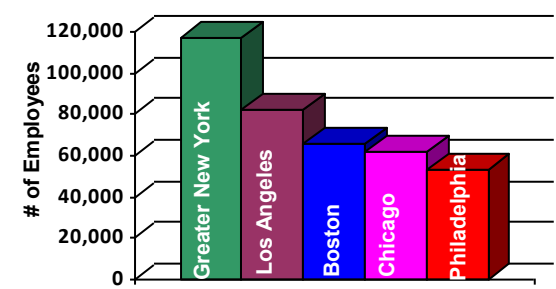
